CACHE COUNTY PRIMARY ELECTION EARLY VOTING

I, Jill N. Zollinger, Cache County Clerk herby give notice of Early Voting in accordance with 20A-3-604 of the Utah Code. Early voting will be conducted in Cache County for the 2018 Primary Election for all eligible* registered voters to nominate Republican Party candidates, Democratic Party candidates and non-partisan candidates listed on the primary ballot. Persons wishing to vote early must be a registered voter in Cache County and MUST PROVIDE VALID VOTER IDENTIFICATION. This is either a form of identification that bears the name and photograph of the voter or two forms of identification that bear the name of the voter and provide evidence of voter's residence. Early voting will be held during the following dates, times and location:

*NOTE: The Republican Party has chosen to allow only voters who are officially affiliated with the Republican Party to participate in their candidate selection process. Registered voters who have not officially declared a political party may vote for the Republican candidates if they are willing to affiliate with the Republican Party at the polls. The Democratic Party has chosen to allow all voters regardless of political affiliation to participate in their candidate selection process. Registered voters in precincts LOG12, LOG13, LOG19, LOG20, LOG21 & LOG23, regardless of political affiliation, are qualified to vote the non-partisan races.
