Garbage Service: RHC contracts with Logan City for garbage service. To pick up a new can go to 153 N 1400

W, Logan. To make any changes to the cans you currently have call RHC at 752-2646.

Garbage day is on Wednesday.

Elementary School: RHC Elementary School is located at 780 East 600 South, 753-4948.

Property Tax: RHC has one of the lowest property tax rates of any city in Cache County at .0123% of

assessed value.

Police Service: RHC contracts with the Cache County Sherriff's Department for police services.

Animal Control: RHC contracts with the Cache County Sherriff's Department for Animal Control Services.

To access their services, call dispatch at 435-716-9400.

Fire & Ambulance: RHC contracts with Logan City for both of these services.

Recreational Facilities: Heber Olson Park at 400 S 600 E: Includes 2 playgrounds, tennis courts, baseball

diamond, volleyball court, reservable pavilion, and a large open grassy area.

Pet Rules: Dogs are required to be licensed by the city and on a leash when in public places. Dogs

are NOT allowed in city parks, except for the Stewart Hill area, north of the cemetery.

City Building: The basement may be rented by residents for \$50 per use and a \$100 deposit. It has a

kitchen, tables and chairs and will accommodate up to 40 people.

Park Pavilion: Schedule through the City Office. Cost is \$25 per use for residents, plus a \$50 deposit.

IMPORTANT INSURANCE INFORMATION

Regarding Potential Water and Sewer Damage

The purpose of this notification is to inform River Heights City residents/homeowners about water and sewer line backup situations. It outlines what to do in the event this happens and explains liability/ responsibility.

- 1. Homeowners are responsible for the maintenance, repair, and replacement of water lines from the meter setter to the house and sewer lines from the main line to the house (**not** just from the sidewalk to your home).
- 2. The City maintains insurance coverage for certain types of damages caused by a direct act or negligence on the part of the City. Most backups, water breaks, flooding, and other damage caused by city provided services are considered "no fault" occurrences (unless of course, the City is found to be negligent in some way). Each homeowner will be responsible to pay for any damage caused by these "no fault" situations.
- 3. To protect homeowners, most insurance policies offer coverage for these "no fault" losses. We recommend each homeowner check their existing coverage and highly recommend making necessary adjustments to policies to keep this extra coverage in force.
- 4. Guidelines for maintaining clean and functional sewer lines:
 - a. **Do not** dump fats, oils (including cooking oil) or grease into your drains. They cool and solidify, causing problems which can lead to backups. These need to go in the garbage.
 - b. Paper towels, disposable diapers (both paper and cloth) and feminine products also cause problems. They do not deteriorate like toilet paper does.
 - c. <u>Please use common sense and avoid dumping these and other problem-causing substances into the system.</u>
- 5. If you experience a problem associated with a city service, call the City Office at 752-2646 or 213-6948 for afterhours emergencies. The City will investigate the main lines, repair as needed, and inform you of our findings. Please keep in mind, a plumber may or may not be able to assist in water and sewer related issues; homeowners will be responsible for costs incurred. Any trouble shooting or repairs to laterals are the homeowner's responsibility and will not be conducted by City employees or equipment.
