#### Motion #4

Councilmember Milbank moved to "adopt the proposed changes to the General Plan, including additional discussed changes, typos, and maps, pending Engineer Rasmussen's decision on the historical overlay zone." Councilmember Malmstrom seconded the motion with Malmstrom and Milbank in favor. Hanover and Mathews opposed. Pitcher was absent. Mayor Wright broke the tie with a vote in favor, which passed the motion.

#### Proceedings of the Meeting:

 The River Heights City Council met at 6:30 p.m. in the Ervin R. Crosbie Council Chambers in the River Heights City Building on Tuesday, July 1, 2025, for their regular council meeting.

Pledge of Allegiance

Adoption of Previous Minutes and the Evening's Agenda: Minutes for the June 17, 2025 meeting were reviewed.

Councilmember Hanover moved to "approve the minutes from June 17, 2025, and the evening's agenda." Councilmember Milbank seconded the motion which passed with Hanover, Malmstrom, Mathews, and Milbank in favor. Pitcher was absent. No one opposed.

#### Mayor and Staff Reports:

#### Councilmember Hanover

- She sent an email to the mayor and council which included a preliminary comprehensive
  emergency plan for River Heights. She asked for input to help determine what they want to
  incorporate into the city's plan. She informed that the county had a lot of resources and that
  she planned to set up a meeting with them.
- She informed there would be a change in the Apple Days parade route. PWD Nelson clarified the reason for the change was that last year they had nearly all the entrances to River Heights blocked off. The new route was to keep more of the main roads open.

#### Councilmember Milbank

 He asked Councilmember Mathews what she had found out about the possibility of a water rate study. Ms. Mathews said she was working with Engineer Rasmussen who was waiting for approval before starting. The cost for the study would be \$4,000. Mayor Wright felt they should go ahead with it. She would give Engineer Rasmussen permission to get started.

#### Mayor Wright

 He informed that Engineer Rasmussen had submitted a bid for work on the water rate study, an impact fee analysis and the 600 South design, needed for the COG application. He had discussed the amounts at the council meeting when the tentative budget was approved. He asked if the council members were okay to have the engineer move ahead with the three studies. They all agreed. Rural Water would do the water rate study for free, but it would take them a long time.

#### Councilmember Milbank, cont.

- He was planning to set up a meeting with Shane Hansen (Providence sexton) and Ryan Snow (Providence city manager) to discuss the installation of a gate between River Heights' new park and the Providence Cemetery. An agreement should probably be made between the two cities. Providence had mentioned they would want compensation for the use of their restrooms.
- He showed photos of some columbarium ideas and suggested the south corners of the new
  park as possible locations. He wanted council approval before he brought the idea up with
  Providence. Councilmember Mathews asked who would maintain them. Councilmember
  Hanover asked what the motivation would be for River Heights to have these in the city park.
  Mayor Wright said cremation was becoming more popular and Providence City was running
  out of room in their cemetery. He and Councilmember Milbank had discussed that adding a

columbarium would be a way to help Providence out. Mr. Milbank pointed out that years ago during a public hearing about what to do with the park property, there were some who wanted the property to become a cemetery. Councilmember Malmstrom felt this could spark some interest in Providence to do the same. Mr. Milbank would present the idea when he met with them.

Councilmember Mathews asked if Chelsea Grant was still going ahead with her memorial plans in the new park. Councilmember Milbank said her enthusiasm was waning. Councilmember Hanover asked if she could come give a report to the Council.

#### PWD Nelson

- He announced that Zoom had been hacked tonight. He suggested a more secure program for electronic meetings. There were inappropriate comments being posted so he shut it down.
- He asked permission to put up "No Fireworks" signs in the parks. Last year there were big messes to clean up on the ground and roofs. The Council agreed. Public Comment: There was none.

Repeal Ordinance 2-2025, An Ordinance Providing for the Compensation of Elected and Statutory Officers of River Heights City: Mayor Wright explained that when this was discussed at the last meeting it wasn't advertised as a public hearing. Also, the treasurer and recorder wages were incorrect.

Councilmember Mathews moved to "repeal Ordinance 2-2025, an Ordinance Providing for the Compensation of Elected and Statutory Officers of River Heights City." Councilmember Hanover seconded the motion which passed with Hanover, Malmstrom, Mathews, and Milbank in favor. Pitcher was absent. No one opposed.

Public Hearing to Adopt an Amended Ordinance Providing for the Compensation of Elected and Statutory Officers of River Heights City: Mayor Wright explained that the mayor and councilmembers increases they discussed at the last meeting were included. The treasurer's salary was adjusted lower, and the recorders was adjusted higher than the last ordinance.

Mayor Wright opened the public hearing. There were no comments.

Councilmember Hanover moved to "adopt Ordinance 4-2025, an Ordinance Providing for the Compensation of Elected and Statutory Officers of River Heights City." Councilmember Milbank seconded the motion which passed with Hanover, Malmstrom, and Milbank in favor. Mathews opposed. Pitcher was absent.

Adoption of Changes to the General Plan: Mayor Wright gave some background. In 2019 the changes were ready to go but COVID hit. The city attorney advised waiting until the public could attend the hearing in person. In late 2021 most of the changes were adopted, except the transportation section. When the Planning Commission recently got back to it, they decided to go through it all again. Horrocks Engineers had been working on a traffic study for over a year, and it still wasn't ready. The city didn't want to wait any longer, so they moved ahead with the transportation section. They could make amendments later, if needed.

Commissioner Heather Lehnig was in attendance to explain the changes the Commission had forwarded after holding a public hearing. She went through the General Plan and discussed the following changes:

- Population updates
- Reduction of the amount of property that can be built on in the city
- Removal of planned unit development references throughout the document

- Inclusion of a potential senior citizen PUD
  - Removal of a strategy to preserve park property adjacent to the cemetery (accomplished)
  - Addition of the historic overlay zone
    - Removal of support for 200 East

- Adjustments to the right-of-way footage
- Clarification that roads that don't meet the standards of a collector road could function as collector roads.
  - Mayor Wright suggested changing "functioning" to "function" in 3.1.3:1.
- Designation of long-term rights of way

Planning Commissioner Cooley arrived at the meeting and took over reviewing the proposed changes.

• Updated water connections and estimated future connections (computed by using the State's formula).

PWD Nelson stated that just because the numbers worked on paper didn't mean they would work in reality.

Mr. Cooley said the city had applied for 3 CFS but it had never been approved. If it were, then the number of future connections could be increased. The only way the city could get approved was by proving that extra water was needed.

PWD Nelson said that the city had 1.5 million gallons of storage, however in the summer months this amount could be used within 24 hours. He said currently, the big difference on the amount of water used was the new park.

Adjustment to fire suppression requirements

Commissioner Cooley suggested the city might consider mitigating some of the city's irrigation shares to convert into culinary water.

• Adjustment to the rent amounts in the Moderate-Income Housing section

Councilmember Mathews asked if the General Plan limited rentals or Airbnbs. Commissioner Cooley said, "No." She asked if there was a limit on the percentage of rentals the city would allow. She was told it wasn't addressed in the city's code. Mr. Cooley stated that because of the size of River Heights, the city wasn't required to file a moderate-income housing report with the state.

- Reword 5.1.2: "As noted in Chapter 1, the current population of River Heights, as of 2023 was 2,180. Based on an average household . . ."
- Remove: "Growth for the five-year period 2000 -2005 was less than 1%" in 1.2.2.
- Remove: "Within some areas of River Heights, there is an allowance for Planned Unit
  Developments which allow for an increase in residential housing density and some diversity of
  housing types, in exchange for the provision of open space and supportive amenities" in 5.1.3.
- Changes to median incomes and housing costs.
  - Councilmember Malmstrom noted that 5.1.4 was double spaced (unlike the rest of the document) and was hard to read. They asked Recorder Lind to put the information in a table.

Councilmember Hanover questioned if duplexes and PUDs should be stricken from the last paragraph of 5.1.4. It was explained that the General Plan addressed the future so it would be left in.

Commissioner Cooley reviewed the maps.

• The property at 660 E 400 S needed to be shown as a historical overlay zone.

Mayor Wright said Engineer Rasmussen had informed that the old school had not been rezoned to be a historic overlay zone. Commissioner Cooley remembered that during the discussions of the old school being designated as a historical overlay zone it was brought up that it didn't need to go through a rezone since it was an overlay. Mayor Wright suggested they get clarification from Engineer Rasmussen.

#### Trails and Parks Map

• The Commission wanted to continue showing a trail going through the Heritage property even though it was no longer going to be zoned PUD.

#### Transportation Map

- New designation for roads that didn't meet the standards of a collector road to functioning collector roads
- Removed proposed connection between 700 S and 800 S on 500 East
- Added proposed road from 700 S to 800 S on 400 E

Councilmember Mathews asked if eminent domain would be used when the road went through. Commissioner Cooley said it would depend on the situation at the time the city felt the road would be necessary. Should they be needed in the future, potential corridors are outlined on a transportation map whether or not they make sense in the present.

<u>Annexation Declaration Map</u> - stayed the same.

Sensitive Area Map – stayed the same.

#### General Plan Land Use Map

- Removed RPUD zone in Riverdale
- Removed RPUD zone east of the church
- Properties along 800 South were changed to R-1-8

Councilmember Malmstrom thought, to be consistent with the surrounding lot sizes, it should be shown as R-1-12.

Councilmember Mathews said they had discussed diversity and change in lot sizes.

Commissioner Cooley explained the thinking of the Planning Commission: If the whole area became one piece and one development, it would be nearly impossible to configure R-1-12 sized lots.

PWD Nelson said if the General Plan showed R-1-8 then a developer would assume they could bring in an R-1-8 development. Commissioner Cooley responded that a developer could still request lots larger than 8,000 square feet.

Councilmembers Hanover and Mathews wanted to show it as future R-1-12.

Commissioner Cooley pointed out that most of the properties were already built on (the north side) and were zoned R-1-8. The Commission suggested continuing that zone.

Mayor Wright noted that R-1-12 would be limiting, while R-1-8 would give the greatest amount of flexibility. If a developer designed a good development where 10,000 square foot lots made the most sense, they would not be allowed if it was R-1-12.

Councilmembers Milbank and Hanover wanted to leave it as agricultural. Mayor Wright said leaving it would open the door to anything, even commercial.

Councilmember Milbank moved to "adopt the proposed changes to the General Plan, including additional discussed changes, typos, and maps, pending Engineer Rasmussen's decision on the historical overlay zone." Councilmember Malmstrom seconded the motion with Malmstrom and Milbank in favor. Hanover and Mathews opposed. Pitcher was absent. Mayor Wright broke the tie with a vote in favor, which passed the motion.

The meeting adjourned at 8:40.







#### **ORDINANCE 2-2025**



### AN ORDINANCE PROVIDING FOR THE COMPENSATION OF ELECTED AND STATUTORY OFFICERS OF RIVER HEIGHTS CITY

NOW, THEREFORE, BE IT ORDAINED BY THE RIVER HEIGHTS CITY COUNCIL THAT:

- 1. **Repealer.** All previous salary of compensation ordinances regarding elected and statutory officers hereby are repealed.
- 2. **Compensation.** The monthly compensation of the elected and statutory officers shall be as follows:

Mayor:	\$1,800.00
Council Members:	\$700.00
Council Member Over Zoning:	\$800.00
Treasurer:	\$1606.80/Salary
Recorder:	\$30.77/hr

- 3. **Payment.** The treasurer shall pay each elected official and the Finance Director monthly. All other statutory officers will be paid bi-weekly. Payments will be by automatic deposit or by delivery of a check drawn on the municipal checking account.
- 4. **Per Diem.** Each member of the governing body shall receive mileage and per diem for all trips approved by the governing body according to the schedules adopted by the Utah Department of Finance.
- 5. Effective Date: July 1, 2025

### ORDINANCE 4-2025

### AN ORDINANCE PROVIDING FOR THE COMPENSATION OF ELECTED AND STATUTORY OFFICERS OF RIVER HEIGHTS CITY

NOW, THEREFORE, BE IT ORDAINED BY THE RIVER HEIGHTS CITY COUNCIL THAT:

- 1. **Repealer.** All previous salary of compensation ordinances regarding elected and statutory officers hereby are repealed.
- 2. **Compensation.** The monthly compensation of the elected and statutory officers shall be as follows:

Mayor:	\$1,800.00
Council Members:	\$700.00
Council Member Over Zoning:	\$800.00
Treasurer:	\$1,111.99/mo
Recorder:	\$31.69/hr

- 3. **Payment.** The treasurer shall pay each elected official and the Finance Director monthly. All other statutory officers will be paid bi-weekly. Payments will be by automatic deposit or by delivery of a check drawn on the municipal checking account.
- 4. **Per Diem.** Each member of the governing body shall receive mileage and per diem for all trips approved by the governing body according to the schedules adopted by the Utah Department of Finance.
- 5. **Effective Date:** July 1, 2025
